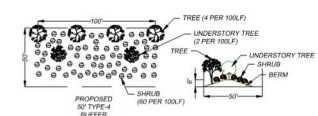
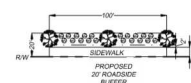

- GENERAL PROVISIONS:
1. DEVELOPMENT OF THE SITE SHALL BE GOVERNED BY THIS PLANNED UNIT DEVELOPMENT PLAN, DEVELOPMENT STANDARDS AND THE APPLICABLE PROVISIONS OF THE CITY OF MONROE UNIFIED DEVELOPMENT ORDINANCE (UDO).
 2. THE SCHEMATIC DEPICTIONS OF THE USES, PARKING AREAS, SIDEWALKS, STRUCTURES AND BUILDINGS, AND OTHER SITE ELEMENTS SET FORTH ON THE ZONING SITE PLAN ARE GRAPHIC REPRESENTATIONS OF THE DEVELOPMENT AND SITE ELEMENTS PROPOSED AND MAY BE ALTERED SUBJECT TO APPROVAL BY THE ZONING ADMINISTRATOR.
 3. ZONING IS TO BE CHANGED FROM RLD (MONROE) & RA-40(COUNTY) TO PUD "EAGLES REST AT LAKE LEE".
 4. A 2' EASEMENT FOR SIDEWALK MAINTENANCE WILL BE PROVIDED ALONG WHITE STORE RD., HWY 601 & MARION LEE ROADS.
